

# A disconnect in overprescribing opioids

t's an epidemic that started long before COVID-19 infected the United States. The opioid overdose crisis continues to claim the lives of tens of thousands of Americans every year.

The misuse of and addiction to opioids, including prescription pain relievers, heroin, and synthetic opioids such as fentanyl, is a national crisis that the Centers for Disease Control and Prevention estimates has caused an "economic burden" of \$78.5 billion a year in the U.S. That includes the costs of healthcare, lost productivity, addiction treatment, and criminal justice involvement.

It's believed that the reassurances by pharmaceutical companies in the late 1990s that patients would not become addicted to prescription opioid pain relievers triggered healthcare providers, including dentists, to prescribe them at greater rates. This led to widespread distribution and misuse of these medications before it became clear that they could indeed be highly addictive.

Even so, dentists nationally continue to overprescribe opioids to their patients despite being aware of the effectiveness of nonopioid analgesics for managing dental pain, according to the results of a Georgetown University survey published in the Journal of the American Dental Association.

In an article on DrBicuspid.com, it is reported that of 269 survey responses from dentists in the U.S., 84% of respondents reported believing that nonsteroidal anti-inflammatory drug (NSAID)-ac-

etaminophen combinations are equally as effective or more effective than opioids. That's nearly double the 43% of those surveyed who reported regularly prescribing opioid medications.

"These results suggest that dentists are familiar with the evidence about the effectiveness of NSAID-acetaminophen medications, but their self-reported prescribing patterns demonstrate a disconnect," said first author Matthew Heron in a statement from Georgetown University Medical Center.

Heron conducted the research as an undergraduate student at Georgetown's School of Nursing and Health Studies.

In Tennessee, however, the number of opioid prescriptions for pain has actually been decreasing in recent years. According to Tennessee's 2021 Annual Overdose Report, 1.96 million prescriptions of opioids for pain were filled in 2016. That number has fallen to 1.26 million filled in 2020, representing a decrease of 35.7 percent.

That same report shows a decrease in indicators of "risky" opioid prescribing practices continuing in 2020, including high dosage and overlapping with other medications.

While the CDC reports that dentists have historically represented the largest prescribers of opioids to adolescents and young adults, data suggests dentists in Tennessee are increasingly working to be part of the solution.

# State of Tennessee dental benefits took effect January 1, 2022

More than 200,000 eligible for voluntary dental benefits plan with Delta Dental of Tennessee

elta Dental of Tennessee, the state's largest independent dental benefits carrier, has been awarded the contract by the Tennessee Department of Finance and Administration, Division of Benefits Administration for the State's fully-insured voluntary dental preferred provider organization program.

"State employees are some of the hardest working members of our communities, and we look forward to providing a comprehensive, value-based dental benefit plan that promotes good oral and overall health," said Dr. Phil Wenk, President and CEO of Delta Dental of Tennessee. "Participants will have access to one of the largest provider networks in the state, ensuring they can access the care they need in their community, from routine preventive checkups and cleanings to a cavity filling or other procedures."

The plan is offered to State employees and retirees, as well as employees of agencies affiliated with the State benefits program. It is developed for the Delta Dental PPO<sup>SM</sup> network, which includes 74 percent of dentists in Tennessee. It is a four-year contract that makes more than 200,000 people eligible for a voluntary dental benefits plan.

The plan took effect on January 1, 2022, and dentists can log into the Dental Office Toolkit for eligibility now.

# Don't let longer delivery times delay your payment

f it seems like your first-class US Postal Service mail is being delivered slower lately, that's because it is.

According to *Business Insider*, the USPS instituted longer delivery times beginning October 1 as part of the postmaster general's decade-long effort to cut costs at the agency.

Prior to October 1, the postal service said delivery for standard first-class mail across the US should take no longer than three days. Under the new guidelines, Americans can expect:

- Mail being delivered 140 or fewer miles to be delivered within two days;
- Within three days for mail traveling between 140 and 930 miles;
- Four days for mail traveling between 930 and 1,907 miles:
- And within five days for mail traveling longer distances.

We know how important timely reimbursement is to our providers, so don't let these changes affect your cashflow. Our network providers still sending claims by mail can cut out the middleman and avoid any delays with our Dental Office Toolkit (DOT) and Electronic Funds Transfer (EFT).

DOT gives your office instant online access to review patient eligibility, check the status of submitted claims and much more at no cost, while helping your office to get paid faster than when you submit paper clams. It also allows your office to avoid the costs associated with physical mailings, like paper, envelopes and postage.

Some offices choose to fax claims instead of mailing them. While faster than mail, faxed claims must still be processed by hand and take several days to input and pay. And payment by check adds even more time to the process.

Electronic claims through DOT for providers who use EFT means that you have money in your account usually within 24-48 hours of claim submission.
